- 1. Preparation of district level road map for SDGs implementation
- 2. Preparation of district profile/fact sheet in respect of SDGs as per targets and national indicator framework (status as on 01.01.2016/current, milestones to be achieved by 2019-20, 2022-23 & by 2030)
- 3. Identification of district priority areas based on status/performance of social, economic and environmental indicators
- 4. Identification of responsible implementing departments/schemes/projects and other stakeholders connected to the priority areas
- 5. Consultation with the departments and stakeholders for identifications of difficulties/hindrances in the implementation of schemes/projects, formulation of locally relevant strategy for effective implementation plans and programs
- 6. Reviews and course correction on effectiveness of strategies and interventions on achieving the SDGs
- 7. Forging of partnerships with local level academic institutions (schools and colleges), civil society organizations, industry and CSR, Youth groups, SHGs federations.
- 8. Capacity building of district, Block and ULBs level functionaries.
- 9. Preparation of District Annual SDGs report.

Committee may invite officials from any other department(s) or organization(s) as special invitee for a particular meeting looking to the requirement.

Meetings of the committee will be convened at least twice in a year and recorded minutes of the meeting will be sent to Director, "Center for SDGs Implementation" Economics & Statistics Department, Yojana Bhawan, Jaipur.
