Minutes of Meeting of State Level Implementation and Monitoring Committee for SDGs

Meeting of State Level Implementation and Monitoring Committee for Sustainable Development Goals (SDGs) was held on 26th April, 2023 under the Chairpersonship of Chief Secretary. List of the officers participated in the virtual meeting is enclosed at annexure 'A'.

At the outset, Joint Secretary, Plan apprised about the SDGs agenda, Institutional Framework at National and State level, roles and responsibilities of various stakeholders and progress made so far in the State.

After the detailed discussion on agenda points following decisions / directions were taken / given in the meeting:-

Agenda 1 – Action Taken Report/ Progress Status on the last meeting of the committee held on 7th March, 2022.

- Committee approved the ATR of fourth meeting.
- Localization of SDGs through LSG
 - ➤ Department of Local Bodies /LSG shall prepare plan of action for orientation and capacity building on SDGs of ULBs Members and officials of all level.
 - ➤ Department of Local Bodies/LSG shall develop Local Indicator Framework (coupled with Municipal Development Index) to monitor the progress of SDGs at local level.

Agenda 2- Approval of Rajasthan Sustainable Development Index, 2023 (Ver. 4.0)

- Committee approved Rajasthan Sustainable Development Index, 2023 (Ver. 4.0) comprising of 83 indicators covering 14 SDGs.
- It was directed that concerned departments should analyse status of each indicator included in Rajasthan SDGs Index Report 2023 to find out gaps and prepare a strategy/roadmap to:
 - > Bring districts at par with State average, whose scores are below State average.
 - ➤ Bring districts at par with their respective indicator's target in State as decided in the Index.

Agenda 3- Approval of Rajasthan SDGs Status Report - 2023 (Ver. 5.0)

• Committee approved the Rajasthan SDGs Status Report - 2023 (Ver.5.0), comprising of 330 indicators.

Agenda 4- Status of SDG Vision Document 2030

- To finalize State's SDGs Vision Document, Chairpersons and Conveners of all Sectoral Working Groups should organize their group's meeting and provide vetted chapters to Planning Department latest by 10th May, 2023.
- Officers in-charge and associated officers nominated by the Planning Department (vide revised order No.F.4(2)Plan/Gr.4/2017 dated 21.10.2022) will coordinate with the concerned convener and chairperson of the Sectoral Working Group to expedite submission of their reports.

- To achieve SDGs agenda and their targets, all departments in coordination with Planning Department and Centre for SDGs Implementation, Directorate of Economics & Statistics should organize training programmes for orientation & sensitization of their officials.
- A revised proposal of dedicated manpower for Centre for SDGs Implementation is to be submitted to Finance Department for effective monitoring of SDGs.
- All departments should form a dedicated cell for effective monitoring of SDGs.
- For effective implementation of SDGs, State SDG team should visit other States for cross learning references. For this purpose, UNICEF shall provide support in identification of States and also provide assistance for the visits.
